

## **BREXIT AND THE IMPACT ON PPE CERTIFICATION**

Since January 1<sup>st</sup> 2021, a CE (Certificates, EU) mark granted by United Kingdom Notified Bodies is no longer recognised by the European Union. Since then, the European PPE EU regulation 2016/425 was translated and amended into UK law, and this Regulation is therefore now effective in both the EU and the UK.

The policy measures announced initially to legally sell PPE in the UK market were giving just one viable way of ensuring UKCA compliance: it must first be assessed and certified by a UK Approved Body to ensure compliance with the requirements of the PPE Regulation 2016/425, and then subsequently affixed with the relevant UKCA mark. Recently there were new UKCA transitional easement measures announced by the Department of Business, Energy and Industrial Strategy (BEIS), this is to take a pragmatic approach to implementing the UKCA mark and to make the transition as easy as possible for businesses. The new measures allow EU Type Examination certificates to be used as a basis for UKCA marking, until these certificates expire (which is latest 31st December 2027). The goods must still bear the UKCA marking as of 1<sup>st</sup> January 2025. The manufacturer can apply the UKCA marking, and the UK importer details via a sticky label onto the product packaging or via an accompanying document (i.e., IFU (Instructions for Use)) until 31<sup>st</sup> December 2027. After the 31<sup>st</sup> of December 2027, the UKCA marking must be printed directly onto the product packaging or product (as applicable).

In summary, to legally sell PPE in the European Union and the UK, it must be dual certified and therefore dual marked with CE and UKCA marks as of 1<sup>st</sup> January 2025.
