Ansell products comply to the requirements of Annex XVII (including relevant amendments) related to the ‘restriction on the manufacture, placing on the market and use of certain dangerous substances, preparations and articles’.

With respect to the Candidate list with “Substances of very high concern (SVHC) for Authorization”, published by the European Chemicals Agency (ECHA) and last amended list on January 16th. 2020; and as required by Article 33 of the REACH Regulation, we confirm that our articles supplied to the EU-EMEA markets currently do not contain SVHC substances in excess of 0.1 % weight by weight with exception of the products listed in Appendix A that all contain DEHP (diethyl hexyl phthalate).
