is in conformity with the following provisions:

the EC-regulation 1935/2004 and the EC-regulation 2023/2006 related to Good Manufacturing Practices (GMP) for Materials and Articles intended to come in contact with Foodstuffs (for more detailed information please also consult Ansell GMP Food Declaration).

All ingredients, starting monomers, additives used in manufacturing this glove comply with:

- any positive list
- any relevant SML(Specific Migration Limit) or restrictions as specified in the applicable EU food legislations.

Regulation (EU) 2024/3190 - no Bisphenol A (BPA) or other hazardous bisphenols are intentionally added to the product formulation of Ansell food contact approved products. Based on a review of the raw materials and formulation information, the product is considered to be in line with the requirements of Regulation (EU) 2024/3190, as corrected by Commission Regulation (EU) 2026/250, specifically:

- Article 3 – Prohibition of the use of BPA: Bisphenol A is not used as an ingredient in product formulation.
- Article 4 – Prohibition on the presence of BPA in food contact materials and articles for which other bisphenols or bisphenol derivatives are used: No BPA is present as a result of the use of other bisphenols or bisphenol derivatives in the formulation.
- Article 5 – Prohibition of the use of hazardous bisphenols: No hazardous bisphenols, as defined under Regulation (EU) 2024/3190, are intentionally used in the product formulation.

This statement is based on current formulation knowledge and supplier information and applies to the product as manufactured under normal, controlled production conditions.
